#### Trailmaster:

On Oct. 10, Carol. Dave W. and Douglas Fisher hiked from the Valentown Museum up to the Kesel property, under the power lines and over to Turk Hill Road to meet up with the Crescent Trail. We will need a revocable permit for the Kesel property and possibly the Cummins and Pickering properties to connect with Perinton. Carol and Douglas will proceed with this. Dave Schaffer from Crescent Trails would like to hike this in the near future.

Carol will investegate where the trail for 100 Acre Woods will be located in the new development off Gillis Road opposite Cobblestone.

## Trail Boss:

On Oct. 16. Larry. Dave W., Rich and Sue started the stone foundations for the new bridge over Great Brook by the RG&E substation on Dryer Road. Each of the wire baskets are nearly half full. We will be loading more stone from the creek Saturday morning at 9 AM on October 30. Anyone that can help, bring boots, gloves and a strong back. We will take measurements for the lumber needed. B.J.'s Wholesale Club has invited us to their store on Sat. Oct. 30 from 8 to 9 AM for a breakfast celebration.

Dave W. has cleared most of the trail around the MaryFrances Bluebird Haven. There is one thick section left to be done around Thankgiving time. Then it can be marked with our blue signs and paint.

Trail Works Inc is holding three workshops to solicit residents input for a trail master plan.

She was delighted and wanted to learn how to start a trail group in her town. Dave sent her lots of information and is hoping for a reply. Dave will leave maps at the local motels, encouraging visitors to try our trails. Also Carol mentioned it would be great to have a trail near Main Street Fishers and 96 for the businesses employees to use at lunch time. Redcom does have some trails on the old trolley bed in the rear of their building. It would be easy to connect with the Lehigh and Auburn. Food for future planning.
