Membership:

Publicity:

Dave W. sent faxes to the local papers regarding our upcoming March hike at Oatka Park near Scottsville. This will be a cross-country ski trek, snow permitting. We could also hike Black Creek Park, time permitting.

Dave W. was interviewed by the D&C and promoted the positive benefits of trails and open space. The article resulted in several phone calls for maps and hike information as well as two new memberships.

Historian:

Dave W. submitted newspaper articles on our Feb. hike, the Genesee Greenway, our March hike. Dave C. submitted an article on banning motorized vehicles in the Adirondacks.

Education:

No report. Roberta suggested a program with local scouts.

Newsletter:

Dave W. has the Spring 2000 issue roughed out and should be ready to mail it on March 1. There will be a trail sweep on Earth Day, April 22; meet 9AM Town Hall.

The deadline for the Summer 2000 issue will be May 25 for a June 1 mailing.

The Town newsletter will be mailed in May. Dave W. will write an article promoting National Trails Day and explaining trail changes and improvements. Any other ideas, please call Dave W.

Trailmaster:

The town has purchased the Rueben's property (1.4 acres) adjacent to the Fishers Park. Charlene Berry-Pickering will determine what needs to be done to the property, including any clearing and repair or replacement of the footbridge.

100 Acres Woods – Carol talked with Jane Luce who will send Carol maps of Hamptons and Wiley Estates to show trail easement. The Planning Board will continue to request open space in 100 Acre Woods and place houses near the main roads.

We have not heard back from any of the landowners on Dryer Rd., so we will go forward with the rerouting of the Seneca Trail where it crosses Great Brook.

Trail Boss:

Larry will try again to reach Debbie Wegman regarding the RG&E property on Dryer Rd.

John McVay got an inventory of pressure-treated lumber available at Larry Fisher's and has a list of what is needed. He will shop around for the best price. He hopes to start in April and finish before National Trails Day.

Trail maintenance 2000 schedule is submitted. See attached sheet.

Larry, Rich and Sue will meet on Sat. 9AM to put the second railing on the bridge over Great Brook at RG&E on Dryer Rd.. The trail will also be trimmed, weather permitting.

Last Hike:

There were 5 hiker/skiers who drove to Webster Park to find it covered with ice from the freezing rain earlier in the week. The group ended up skiing in Perinton on the Hike-Bikeway that used to be the R.S.&E. (eastern) Trolley line. They parked at the Ayrault Rd. crossing, skied to the Canal, skied on the canal, had lunch and returned to their cars. We will put Webster Park on our schedule for next year for a <u>non-snow</u> month.

Old Business:

Our National Trails Day event is listed on the American Hiking Society website. Dave W. submitted our application for the Community Millennium Trail.

Dave W. attended the monthly BPAC meeting. They are reevaluating the program and want to include more emphasis on the pedestrian factor.

The town expects to have GIS map training and software by June 2000.

The Victor Historical Society Advisory Committee made a report to the Society board. The board is starting to have meetings to determine what the long-range plan of the museum and surrounding lands should be.

New Business:

Dave W. sent a copy of our insurance policy to George Harris, attorney to Evelyn Harloff, owner of a property on Dryer Rd. where our Seneca Trail crosses.

The Transportation Plan, conducted by SRF & Associates, was adopted by the Town Board as an addition to the Town's Comprehensive Plan (Master Plan).

Bristol's Farm Market has purchased the property adjacent and to the south. They will use it for storage of their inventory.

Crescent Trail hike for March 12 will be at Bushnell's Basin on Jefferson Rd. just north of Thornell Rd.. They will hike the southwest area trails from Cartersville to Garnsey Rd..

The DEC has two brochures on wetlands and their benefits.

Crew 215 is going through some growing pains. The scouts are mostly seniors and are involved in many activities. Bruce Mellen, the Crew advisor, would like to see the group continue, but the scouts need to take the initiative to recruit younger scouts, elect officers and plan their activities.

The University of Buffalo has financial assistance for graduate studies in Environmental Planning. Students accepted in their Master of Urban Planning program and who wish to specialize in Environmental Planning, are eligible for a \$5,000 "top-off" fellowship. For our May hike at Spring Farm, we must sign an agreement to leave the facilities as we find them and be responsible for any damages. They also request that we provide a satisfactory certificate of insurance for the day we will hike. Dave W. will send in the paperwork.

The ZBA is reviewing a request of the RKH Golf driving range on Lynaugh Rd. for five 40' light poles (code specified 25'). The next meeting will be Mon., March 6, at 7:30PM.

Nancy Young is selling her property. 3-8 acres with the house will be put on the market and about 60 acres adjacent to the Fishers Park will be offered for sale to the town. Chauncy has indicated that he would offer to donate his 1/3 to the Town, if the Town purchases the entire 60 acres as parkland. He currently maintains trails on the property.
